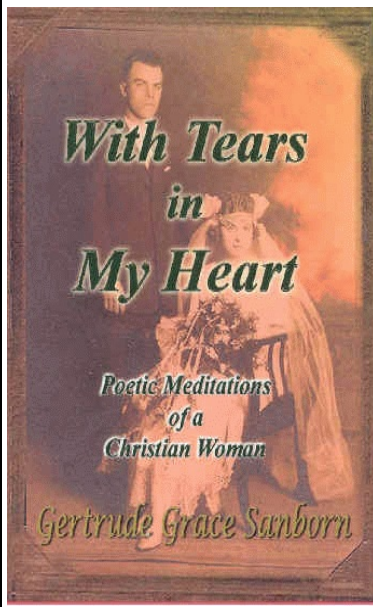

BIBLICAL & POLITICAL LESSONS LEARNED

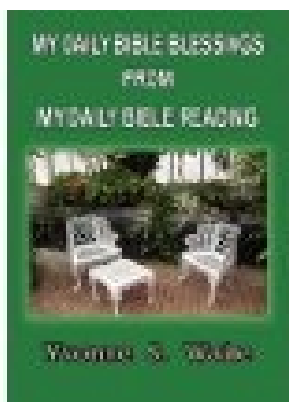

IT WAS IN NEWTON, MASSACHUSETTS, THAT DR. D. A. WAITE BUMPED RIGHT UP AGAINST NEW EVANGELICAL THOUGHT & PRACTICE. Come to find out, we were living in the backyard of BOSTON'S PARK STREET CHURCH where DR. HAROLD OCKENGA reigned from 1936 to 1969. Many of the sermons from Park Street's pulpit are found in Ockenga's books. If I remember correctly, Dr. OCKENGA was in Carl & Fairy McIntire's wedding. He was an usher. I listened to Dr. Ockenga on the radio when living in Newton. He was a fluent, influential speaker and very interesting, but he spread his *new evangelical thought* with every word.

OCKENGA'S DISGUST WITH BICKERING

HAROLD OCKENGA WAS THE FATHER OF NEW EVANGELICALISM, teaching his doctrine and ideas in every direction to whomever he could in his Jerusalem, in his Judea, & in his uttermost part of the world (Acts 1:8). If you remember Dr. OCKENGA was a founder of FULLER THEOLOGICAL SEMINARY on the West coast. He was the first & third president, ruling from Boston's Park Street Church from 1947-1954 and 1960-1963. He was its board's chairman until 1981, and had much to do with the publication of *CHRISTIANITY TODAY* (chairman of the board for years) until 1981 with EDITOR CARL F. H. HENRY & NELSON BELL (Billy Graham's father-in-law). Ockenga was the scholarly NATIONAL ASSOCIATION OF EVANGELICAL'S founder and first president (1942-1944). I believe it was his influence that pushed BILLY GRAHAM away from FUNDAMENTALISM into the NEW EVANGELICAL fold. I had forgotten until now that Ockenga merged two seminaries (GORDON & CONWELL) striving for a Fuller Seminary-type school on the East Coast. He was its president from

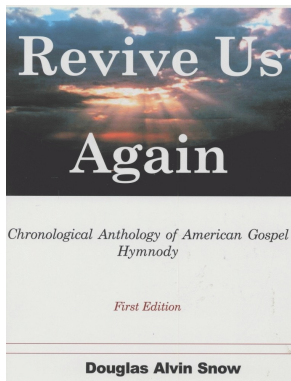
1970-1979. I remember, Dr. Ockenga was rather disgusted with fundamentalism and its bickering. He wanted a more scholarly approach to his religion! As it turned out, much of the controversy, I'm told, was over Biblical inerrancy, creationism, evolution, the deity of Christ, the virgin birth, and Christ's resurrection, as well as His Second Coming.

VOICING CONSERVATIVE THOUGHT

So it was in this bed of NEW EVANGELICALISM, that PASTOR D. A. WAITE, fresh out of the Navy chaplaincy, dug deep into the roots of his Biblical understanding & convictions, becoming a SEPARATIST. Perhaps he remembered his high school days and the daily news commentators which were heard around his family's dinner table. His father, CHEMICAL ENGINEER VIRGIL H. WAITE, by example, taught his son what it meant to be an American and A POLITICAL CONSERVATIVE AMERICAN! Little did my husband know that, at that time, his father was secretly working on a project that would win what is called today "WORLD WAR II"!

While in Newton, Mass., Dr. Waite recalled searching for truth back in his Dallas Theological Seminary days in Dallas, Texas. He remembered the time when he met and shook the hand of H. L. HUNT, who was, in those days, the wealthiest man in the world. MR. HUNT and his son, Bunker, introduced SEMINARY STUDENT D. A. WAITE to MR. DAN SMOOT and his FACTS FORUM radio program. YES, WAY BACK IN DALLAS, TEXAS, WAS THE BEGINNING OF MY HUSBAND'S political conservative forth telling!

How well I remember the opposition! OUR CHURCH SIGN WAS DEFACED WITH RED-ORANGE PAINT! Also a SWASTIKA was painted on the side of our garage. Then ONE NIGHT SOMEONE THREW A STONE THROUGH OUR FRONT WINDOW!

You may wonder why this "Ohio boy" can stand tall when some of his so-called "friends" make fun of his personal conservative and Constitutional views. Some even call him a "crackpot"! **These convictions have been embedded stanchly in the heart of D. A. WAITE since the days of living in NEW ENGLAND--the land founded by our Pilgrim fathers!** You may ponder why my husband faces the day's daily news with skepticism, searching for the truth behind the lies. IT ALL BLOSSOMED IN NEWTON, MASSACHUSETTS!

THE BEGINNING OF "THE BIBLE FOR TODAY"

A RADIO PROGRAM BROADCAST FROM RHODE ISLAND

When my husband was the pastor of the FAITH BAPTIST CHURCH, which met in its large Victorian parsonage in Newtonville, Mass., at the time, he began a radio program which was broadcast out of a station in nearby Rhode Island. This was during the time period around 1960 to 1965—give or take a year or so. (Our youngest son was born here in Collingswood in October, 1965.) The program was called “THE BIBLE FOR TODAY.” The theme was the gospel song, *IN TIMES LIKE THESE, WE NEED A BIBLE*. ALL THIS WAS BEFORE DR. WAITE BEGAN STUDYING THE TEXTUAL ISSUE FOR WHICH HE HAS BECOME WELL-KNOWN AROUND THE WORLD TODAY. In other words, the radio program’s purpose was to apply the Bible to the issues of the day. This program was broadcast for several years, not only on the Rhode Island station, but also in Florida. Maybe on other stations also—I can’t recall. (I was busy being a mother of five children at the time.) The program was aired after we moved to Collingwood, NJ, also. It was a joy!

DR. WAITE & NEW YORK CITY RADIO SHOWS

Often during our first years in Collingswood, NJ, Dr. Waite was called upon by various New York City radio show hosts, like Barry Farber and others, to speak on various issues pertinent to current events and Biblical interests. That was in Radio City, I think. I remember walking down a hall and looking into a door window seeing the taping of THE TONIGHT SHOW. I wish I could remember which I saw, whether JACK PARR or JOHNNY CARSON on the stage.

Come to think of it, my husband was called upon to do such radio refutations while we were in the Boston area, too. I think that is right. It was an exciting time! Often I went with him. I met some very interesting individuals during those times, and saw very different sights as well as extremely odd people who were walking the night streets of New York City. Those talk-show hosts were prominent radio personalities. Their guests were unique book authors with “way-out ideas” or views on current affairs. Once my husband did a program with JACK WYRTZEN. Though he mentioned the program when he talked and wrote about it to others, he never said that my husband was also on that program. In fact, when asked by the radio host who could come on the broadcast with him, my husband recommended Jack Wyrzten. So much for equal billing!

After awhile, my husband decided the Lord would have him “go it alone,” so to speak, he rejuvenated THE BIBLE FOR TODAY, not with a radio program, BUT by way of THE BIBLE FOR TODAY NEWSREPORT. The NEWSREPORT went into hundreds of homes in the USA & in other countries. Often people ordered items from us. Some of the “offers” were written or spoken on tape by Dr. Waite. Others were written by other people on vital subjects which applied the truth of the Bible to the issues of the day. All this while, Dr. Waite was a “TENT MAKER” (Acts 18:3) to support our five children and me, as well as supporting THE BIBLE FOR TODAY MINISTRY and its staff. He taught in the Philadelphia school system for nineteen years. It was at JOHN PAUL JONES JUNIOR HIGH where the children could care less about learning and obedience. Most of his time was spent keeping the class in order. Little did they know what a brilliant teacher they had. How much they could have learned if they only wanted to!

The children and I appreciate what Dr. Waite did for us all those years. And you—if you have read his books and papers composed during those years, you, too, have benefitted from those nights of studying and writing about the issues of the day and the defense of the King James Version of the Bible and its underlying text.

WHAT HAVE WE BEEN DOING ?

THE INTERNAL REVENUE SHOCK TO THE DEAN BURGON SOCIETY

Although **THE BIBLE FOR TODAY** & THE DEAN BURGON SOCIETY are two separate organizations, I thought you **BIBLE FOR TODAY UPDATE** readers would be interested in some current news pertaining to THE DEAN BURGON SOCIETY. Both of these ministries (BFT & DBS), as well as our church (the Bible For Today Baptist Church), meet in our home here at 900 Park Avenue in Collingswood, New Jersey. My mother used to call our house “FORT 900”-and I think she was right!

INTERNAL REVENUE’S CRACK DOWN

Perhaps you have read in newspapers like THE SWORD OF THE LORD NEWSPAPER

(OUT OF MURFREESBORO, TN) or other news sheets that the INTERNAL REVENUE SERVICE has cracked down on ALL TAX EXEMPT ORGANIZATIONS. It has been said by the IRS itself that as of May 15, 2010, the IRS removed 430,000 tax exempt organizations from their tax exemptions. Evidently the organizations had failed to fill out the 990 forms for three consecutive years. Because of this, the tax exempt status was withdrawn automatically.

DBS NO MEMORY OF SUCH NOTICE

Thousands of tax exempt groups had their tax exempt privileges snatched from their organizations. THE DEAN BURGON SOCIETY WAS ONE OF THEM. THE DEAN BURGON SOCIETY HAS NO MEMORY OF RECEIVING SUCH NOTICE! Others, like the DBS, did not remember receiving such notice via the mail either! So--thousands of 501(c)(3) groups were shocked out of their boots with such news!

NO LONGER TAX EXEMPT

NO LONGER TAX EXEMPT?! Yes, THE DEAN BURGON SOCIETY WAS ONE OF THOSE 501(c)(3) non-profit organizations that received such SHOCKING news! Soon, we heard from other 501(c)(3) friends that they, too, had their tax deductible privilege taken from them. They, too, had no memory of receiving such a notification. (Receiving a notice from the IRS is something one does not forget or overlook!) All will be restored, from the date of its withdrawal, when our new application is accepted.

DILIGENTLY FILLING OUT FORMS

True, up-to-date tax accountants knew of the IRS change of their rules, as well as some lawyers, but many of the 501(c)(3) recipients did not know this unwelcome news! So, Treasurer Daniel Stephen Waite and President D. A. Waite worked many days, diligently filling out 30 pages of IRS forms, gathering five pounds worth of DBS documentation, and sending it to the IRS along with the \$850.00 application fee.

OTHERS NEVER TRIED TO GET A DEDUCTION

It must be pointed out that several friends of ours, in Christian ministry, have never had a tax deductible number. They get tax deduction through their local church. It is not an easy thing to fill out all those forms. Many of those that did file hired an expensive lawyer to do the job. Dr. Waite did this by himself 33 years ago when the Society was first established. It was not an easy task! My husband did not charge the Society for this-as he has not charged it for any of the many thousands of hours of work that he has given to the cause all these thirty-three years.

NEVER BEFORE

Up until this year (2012), the DEAN BURGON SOCIETY had never been required to fill out any yearly forms. The reason being that the DBS never took in more than \$25,000 a year! NEVER BEFORE WAS THE DBS REQUIRED TO FILL OUT INTERNAL REVENUE 990 FORMS! You see, ALWAYS BEFORE those non-profit organizations, that took in \$25,000 or less a year, did not have to fill out any 990 forms or pay any money to the IRS. THIS IS HOW IT WAS FOR THE DEAN BURGON SOCIETY FOR THE FIRST THIRTY YEARS. We didn't know that the law was changed three years ago which made it necessary to file the 990 forms during those years.

AN IRS COPY COULD NOT BE SENT

Neither DBS PRESIDENT D.A. WAITE nor DBS TREASURER DANIEL STEPHEN WAITE REMEMBERED EVER RECEIVING SUCH A NOTICE!! You can believe, if they had received it, they would have complied and sent in the form 990! Upon learning the *shocking news*, Dr. Waite called the INTERNAL REVENUE PEOPLE ASKING FOR A COPY OF THE NOTICE THEY SAID THEY SENT TO THE DEAN BURGON SOCIETY. The IRS denied such a request for they informed my husband that all their letters to the 501(c)(3) organizations are computer-generated and it would not be possible to send Dr. Waite a copy of the letter from the IRS, that they said they sent to the Dean Burgon Society.

FRIENDS RECEIVED NO NOTIFICATION EITHER

Soon we heard from other 501(c)(3) friends that they, too, had their tax deductible privilege taken from them. They, too, had no memory of receiving a notification. (Receiving a notice from the IRS is something one does not forget or overlook!) True, most up-to-date tax accountants knew of such, as well as some lawyers, but many of the 501(c)(3) recipients did not know! So, Treasurer Daniel Stephen Waite and President D. A. Waite worked many days, diligently filling out 30 pages of forms, gathering around five pounds worth of DBS documentation and sending it to the IRS, along with the \$850.00 new application fee.

Those that do, might get an expensive lawyer to do the job. Many just gave up! Dr. Waite did this by himself 33 years ago when the Society was first established.

PRAYER ASKED FOR THE SITUATION

Still stunned—yet rejoicing that the job was done and sent off to the IRS, Pastor Waite asked for prayer in our church and in our BIBLE FOR TODAY BAPTIST CHURCH BULLETIN, which is sent weekly by PDF/E-MAIL to hundreds of people. Those people are not only our BFTBC church people, but also friends that include all the Dean Burgon Society's EXECUTIVE COMMITTEE and THE ADVISORY COUNCIL (Notice, the DBS does not have "BOARDS.") THE RECIPIENTS WERE ASKED TO PRAY. That was when the trouble and accusations began!

SHOCKING ACCUSATIONS

I am not going to narrate the shocking, unkind remarks, and the accusations that came by e-mail to my husband's eyes from two DBS leaders. (These remarks and 14-pages of answers by Dr. Waite are available upon request.) They implied that the DBS TREASURER & DBS PRESIDENT were dishonest embezzling thieves (in so many words)! ONE of the DBS Leader/e-mailer demanded a copy of the 30-page IRS application and enclosed papers, as well as making accusations that the DBS had two sets of books—one set for the DBS business meetings and another set for the Internal Revenue. NONE OF THIS IS TRUE! Never were we so shocked!!!!

WHICH WAS THE GREATER SHOCK?

Dr. Waite and I loved and trusted these two accusing DBS leaders like sons. It was bad enough to lose the DBS TAX DEDUCTIBLE STATUS (temporarily, we hope), but then we were ATTACKED by DBS leader "friends?" whom we loved. They implied that we were "thieves" and "deceivers"! I don't know which was a greater shock!—temporarily losing the tax deduction or reading these "brothers/sons" accusations!

A FEW WORKS BY DR. D. A. WAITE
